- Motion to work with ReachScale, a MA LLC in partnership with Jefferson and Wilkinson County on the preparation and submission of a Department of Energy 2023 Energy Future Grant Creating a Community Led Energy future to,
 - 1) Create multi-jurisdictional partnerships between local, tribal and/or state governments.
 - 2) Develop deployment-focused clean energy plans in the transportation building, and/or power sectors to meet community needs, and,
